#### *Part 1 : Sharing of COVID-19 Control Measures in Utility Works*

Speakers : *Mr. Victor Kwong, The Hong Kong & China Gas Co., Ltd. (Towngas)*  
Mr Victor Kwong is General Manager – Corporate Sustainability and Chairman of the Towngas Environmental Working Committee. He is also Director of Business Environment Council, Immediate Past President of The Hong Kong Federation of Occupational Safety and Health Associations, etc. Towngas operates over 250 projects in Hong Kong and Mainland China. These include piped city-gas projects, upstream, midstream and downstream natural gas sectors, water sectors, efficient energy applications and exploration & utilization of emerging environmentally-friendly energy, telecommunications etc. Mr. Kwong has more than 35 years of experience in the areas of corporate sustainability, environmental protection, occupational health and safety, fire protection and crisis management. He coordinates the corporation's efforts to improve sustainability and safety performance through effective risk management system, energy saving programs, carbon reduction, climate change risk reduction, etc.

#### *Ms. Maisie Mei Sin Wong, MTR Corporation Limited*

Ms. Maisie Wong is a safety and health professional with 15 years of experience in transportation, and manufacturing industries. Maisie is the Manager of Safety and Health in Corporate Safety Department for MTR Corporation with rail and property operations in Hong Kong, as well as in UK, Sweden, Australia, and Mainland China. She devotes herself to be a Chairman of Editorial Board of Society of Registered Safety Offices of Hong Kong (SRSO). Maisie holds BS(Hons) of Chemistry from the University of Science and Technology of Hong Kong and Master Degree of Environment from the Melbourne University. The talk will address the aspiration of global 'Vision Zero' movement, and the systems and processes organisations need to take on the journey in reduction health and safety accidents. The speaker, Ms Maisie Wong, will discuss how MTR Corporation takes on 'Vision Zero' and transforms it into its own Zero Harm campaign with an aim to promulgate a preventive safety culture among the workforce. Ms Wong will discuss the impact of COVID-19 to the workforce under the new normal, and offer helpful tips for management to achieve a high level of health and safety using the Zero Harm approach during this difficult time.
